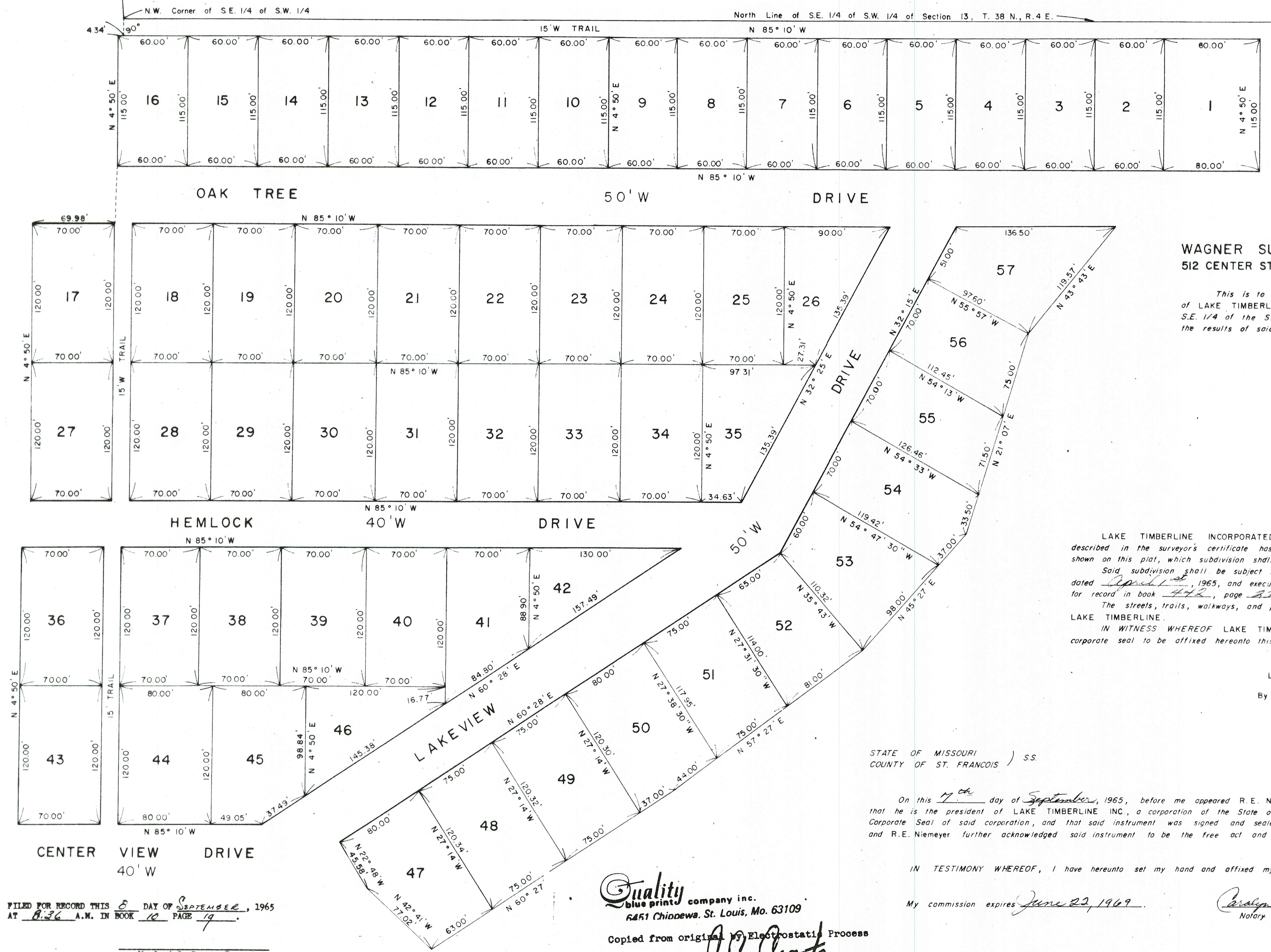


# LAKE TIMBERLINE PLAT 5 BLOCK 5

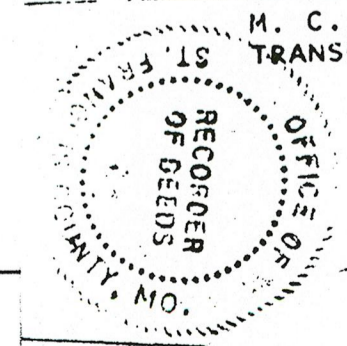
