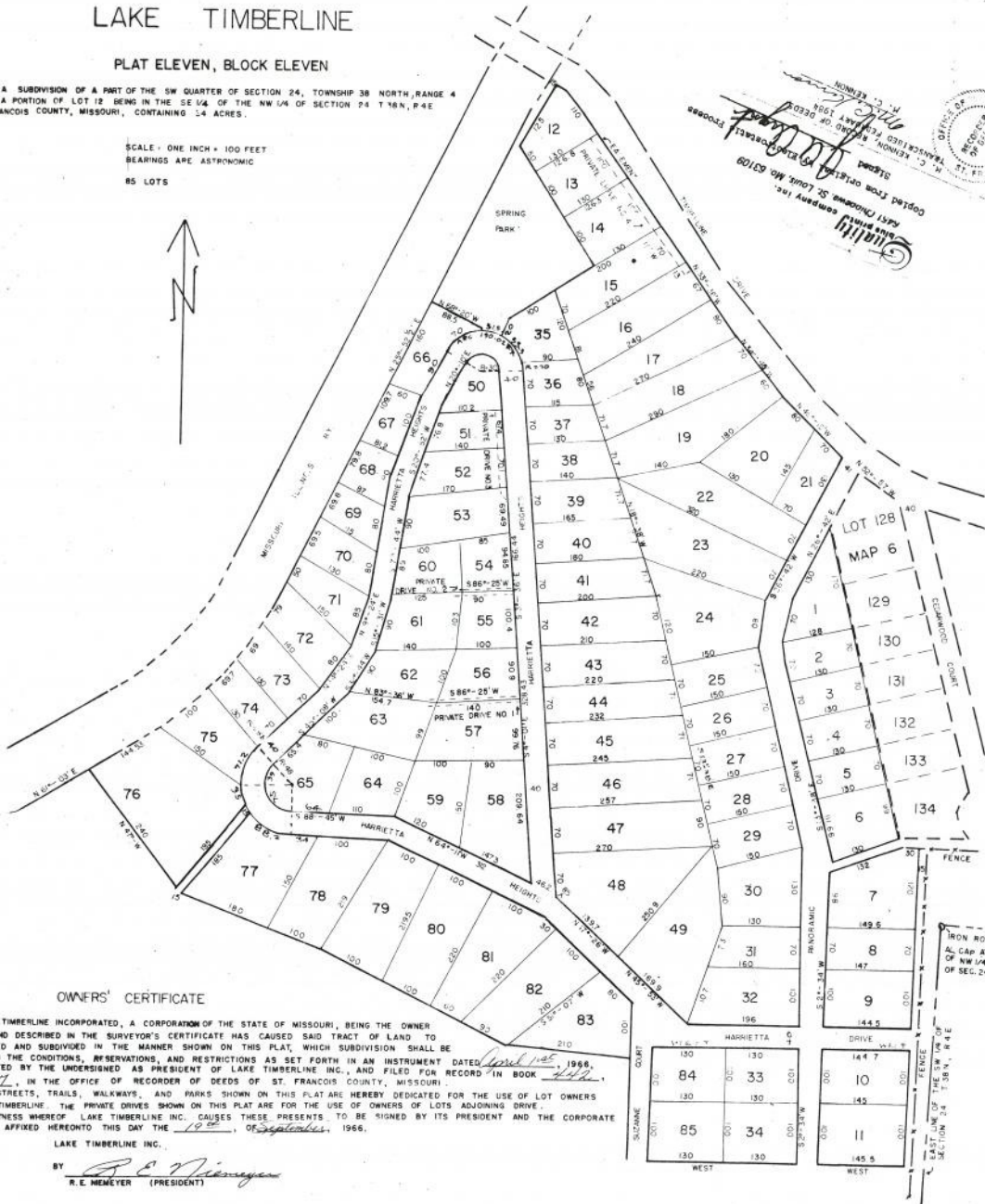


LAKE TIMBERLINE
