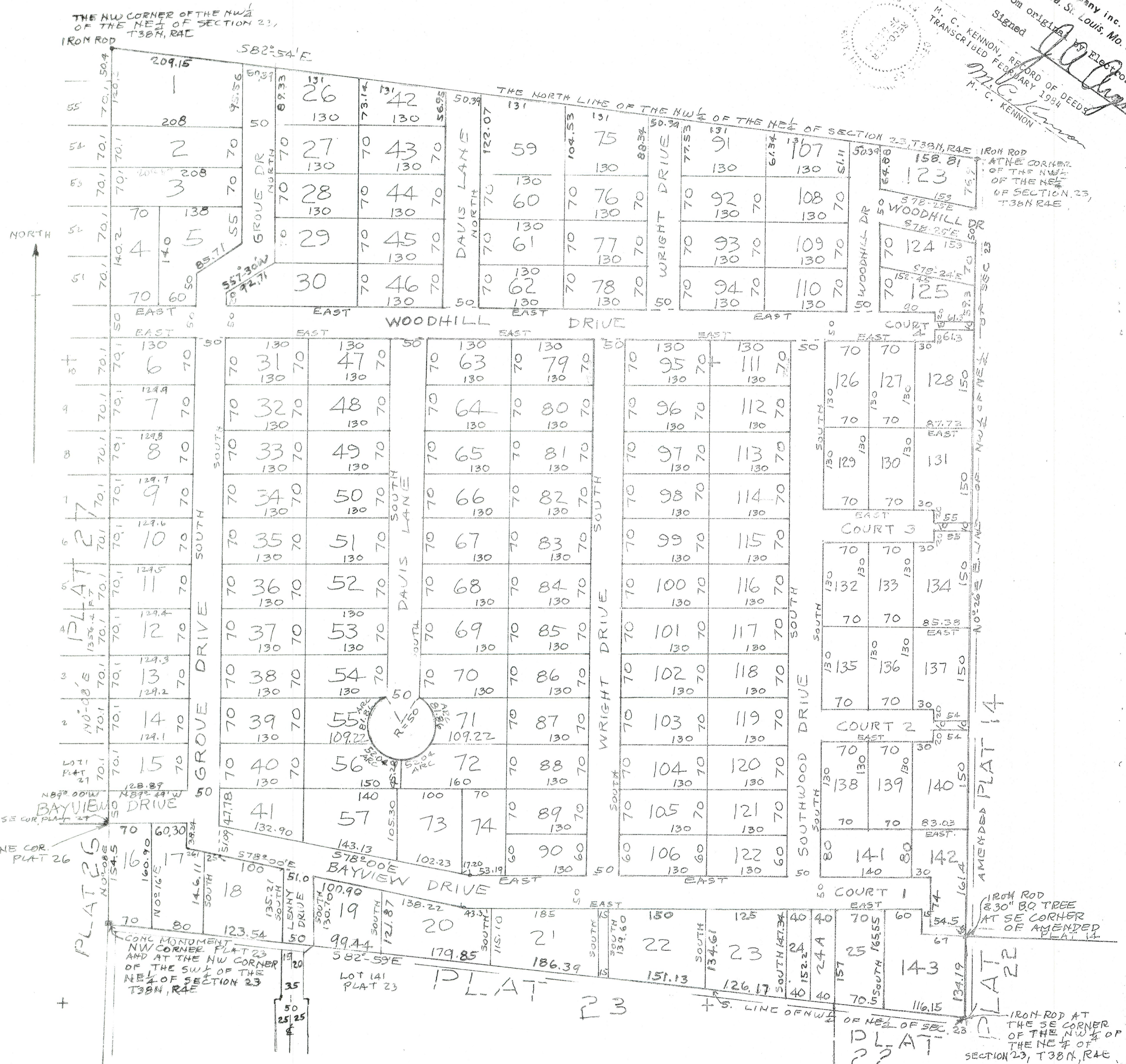


LAKE TIMBERLINE, PLAT 29
