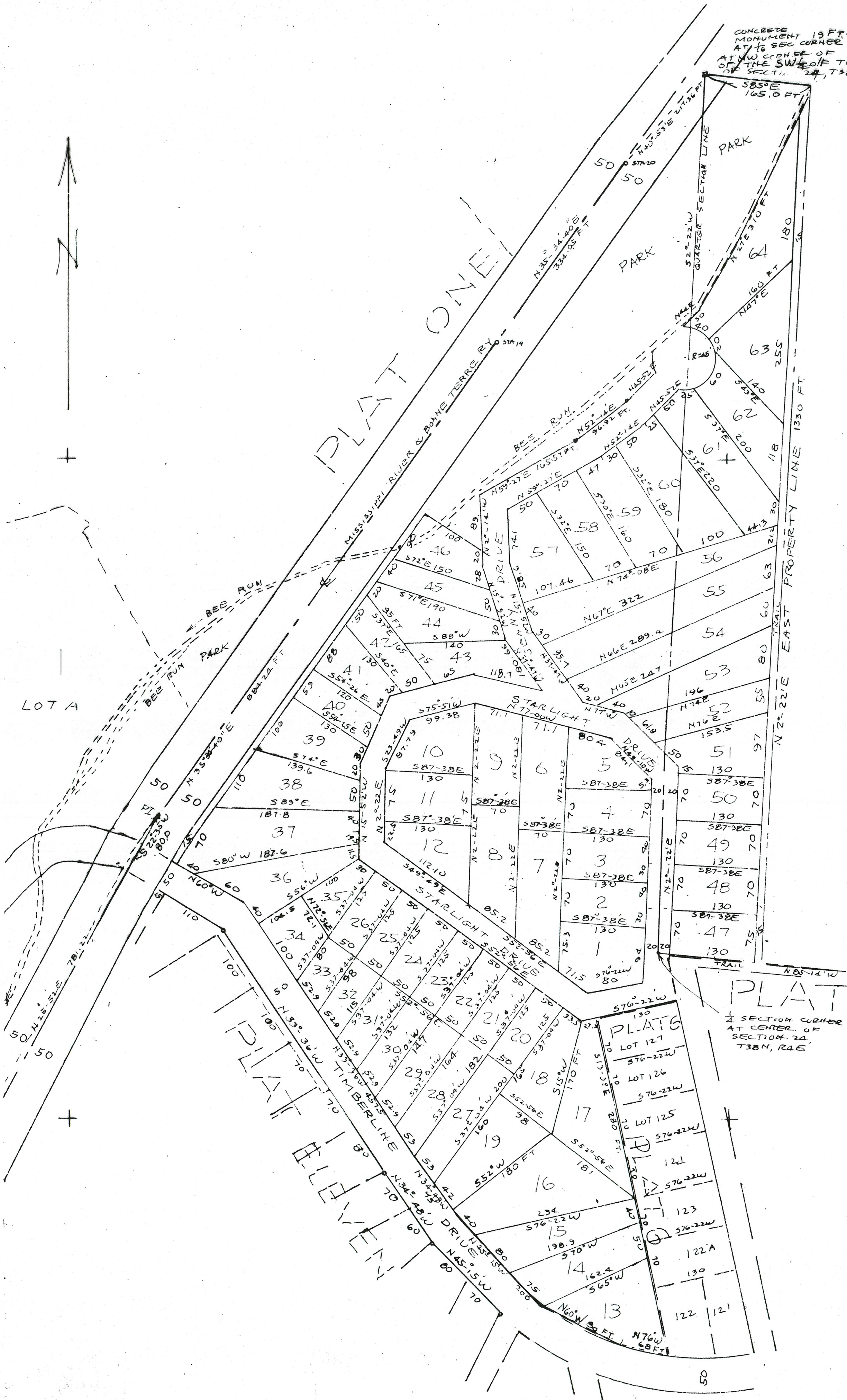


LAKE TIMBERLINE PLAT 15, BLOCK 15

OWNERS' CERTIFICATE
